Seller will provide insurance coverage to protect against any loss by fire, theft, or other damages during this agreement even though vessel may be stored at DBSS facilities and agrees that DBSS shall in no instance be liable for any loss or damage to Seller's vessel. It is further understood by both parties that in the event of theft, damage, or vandalism to the vessel or its contents, Seller relinquishes and waives any right to recovery which Seller may have against DBSS including but not limited to all claims for negligence and/or breach of contract.
